## FSSAI Registration

### (Requirements)

-  **Identity Proof:** PAN card and Aadhaar card of the proprietor/partner/director.
-  **Business Address Proof:** Utility bill, rental agreement, or ownership proof.
-  **Photograph:** Passport-size photo of the applicant.
-  **Nature of Food Business:** Details of food items or services offered (e.g., manufacturer, retailer, distributor).
-  **List of Products:** Names/categories of food items to be handled.
-  **Turnover Details:** Declaration of annual turnover to determine the license type (Basic/State/Central).
-  **Form B:** Duly filled and signed application form (Form B) as per FSSAI guidelines.
-  **Other Documents (if applicable):** NOC from municipality, kitchen layout plan, food safety management plan, etc.
